I may look to push the workshop further into 2021 to have the best chance of putting the COVID-19 pandemic behind us.

EXHIBITION DIRECTOR'S REPORT Jean Cannon

- 1. Summer show, "Into the Woods" at the Gruppe Gallery in Jericho opens July 25th. Thirty four paintings by 34 artists on display. Lisa Beach's piece was chosen for the postcard image and the postcards were designed by Jeanette. 250 were delivered to the gallery and each of the exhibiting artists got 15 to distribute. In lieu of an opening, it was decided to have "meet the artists" Saturdays and Sundays for the duration of the show. There are 10 Saturdays and Sundays and 4 artists have signed up for a slot. The artist's schedules will be posted on the gallery website.
- 2. The fall awards show at the Chaffee Art Center is scheduled to open September 11th. Deadline for entry is July 15th and as of this writing 7/11, 20 artists have submitted 35 pieces. So far we have a firm commitment for \$1300 in awards. Unfirm, but probable for another \$200. I have not heard from Holbein, who were very generous last fall with material awards.
- 3. In the Spring of 2021 we have a verbal commitment from the Highland Center for the Arts, but no dates and no contract. This show is supposed to be in conjunction with a workshop.
- 4. Fall of 2021 our awards show is scheduled for the Festival Gallery in Waitsfield. Opening reception is October 24th and the show will run until December 17th.
- 5. Jeanette has been in touch SBAC for 2022 for the Spring Show

TREASURER'S REPORT

Due to the pandemic, financial activity in the VWS accounts has been minimal over the past two months. For May and June we collected \$105 in dues and \$175 in fall show entries. Disbursements have been even less at a whopping \$217.95 spent in two months. Consequently, our financial status remains the same. We have over \$30,000 as available resources.

After some long delays due to the pandemic, Mary Stuessy and I were able to discuss the possibility of her taking on VWS as a new client. (Lauren Wooden had suggested I contact Mary after Betty advised that she was reducing her client load). Mary had some great ideas about how to digitize the check processing payment system so we could avoid some of the long delays we experience shuffling invoices and checks over snail mail. She also would use quickbooks online (versus the desktop version we currently use) so I could access financials directly, or look up expense questions without going through an intermediary. Mary would charge us a flat fee of \$150 per month (which includes the subscription to quickbooks online). This would be \$1,800 per year, and last year we spent \$2,100. Our budget for 2020 is \$2,000. I recommend that we change bookkeeping services effective 9/1/20 to Grasp Books.

- 1. Newsletters continue to go out by the first of the month. As a Board we have successfully posted the "Why I Serve" column each month since January with only two more of us to go. I will write something for the August Newsletter and Angie will finish with September. Good job everyone and thank you. Hopefully these postings will help us fill the Board vacancies this Fall.
- 2. The Newsletter is sent using a service called Constant Contact. To date it renews automatically every year. The next billing cycle begins on 8-9-20 thru 8-9-2021. I called them to let them know we will no longer be using their service, so we have until 8-9-2020 to send any emails using Constant Contact. There is an option to archive all work that has been done through their site, including retention of the current mailing list, for \$5.00/month. I declined this service. The case number for the cancelation is #26851944.
- 3. I signed up for two webinars this week to acquaint myself with using Mailchimp, our new email platform. One is on basic orientation and the other on how to create a new Template. Before I try to create one, I'd like to know if a template has already been set up by Natasha?
- 4. We now have 500 VWS bumper stickers at our disposal. They're really nice and very visible. I have one on our car. The question is how do we want to distribute them? I outlined a few thoughts in an email earlier this month directed to the Board. Ideas included:
 - For starters we could have them at the Gruppe Gallery during the upcoming show?
 - We could mail them out to members, (but would need to include the mailing costs of doing so)?
 - We could keep them until the Fall meeting and hand them out then?
 - I could mail bundles to HUB leaders for their distribution needs?

Discussion: Martin Lalonde made a motion to snail/mail the bumper stickers and include information about the Fall show, future meetings, including the new brochure, and letter to encourage members to volunteer for Officers Board Members mailing to members, with some members divided into special categories. Chris seconded the motion. Laura will mail the labels, Martin will write the letter, Judith and Martin will mail it. The motion passed unanimously.
